Mr. Winchell noted that it is the time of year that we normally receive notification from employees who are making alternate plans for the next school year, we anticipate we will have more changes in the coming weeks.

NEW BUSINESS

1. Approve High School Summer School Staff

Mr. Winchell noted that we are currently arranging summer school staff for our students. We typically run one class per grade level at the elementary and middle school levels. At the high school, we typically offer physical education, health, math and several online classes. We will likely have more than one class per grade level this year. The recommendations you have before you today are for the high school staff, we will have an additional recommendation for the elementary and middle school staff at the next meeting. Mr. Christian Mattix made a motion to approve High School Summer School Staff and Mr. Jared Egger seconded the motion. The motion carried with a vote of five to zero.

2. Approve Change Order for Urey Middle School

Mr. Winchell reminded the Board that there is a hallway at Urey Middle School immediately to the right when you come in the doors by the gymnasium. This hallway and ramp provides handicap accessibility to this side of the building. Over the years, the snow load that piles up on that roof each winter has damaged the structure and integrity of the hallway. At this time, this entry way and hallway are closed due to it not being structurally sound. Since this project is over \$25,000 and outside the scope of the previously approved projects, it requires special Board approval. We have attempted to collect three bids, as per policy. We are pleased to recommend Brown and Brown Construction for a project total of \$56,388.91. After a brief discussion, Mr. Ryan Knowlton made a motion to approve Change Order for Urey Middle School and Mr. Dan Drotar seconded the motion. The motion carried with a vote of five to zero.
