

## **School Board Meeting – June 18, 2019**

### **Regular Session**

CALL TO ORDER AND ROLL CALL – 7:00 P.M.

ESTABLISH A QUORUM AND PLEDGE OF ALLEGIANCE

The Board of School Trustees of the John Glenn School Corporation met in regular session at 7:00 p.m. on June 18, 2019, at the John Glenn Administration Office. Board members present were Jeff Johnson, Bob Borlik, Christian Mattix, Dennis Holland, Bill Groves, Curt Pletcher, and Dan Drotar. Richard Reese, Superintendent, and 24 observers were also present.

1. Approve John Glenn High School Band Camp Staff

Bill Groves made a motion to approve the summer band camp staff as presented. Jeff Johnson seconded the motion, and the motion passed with a vote of seven to zero.

2. Approve Resolution of Official Intent to Reimburse Expenditures

Mr. Bendy asked the Board to approve a resolution to allow for reimbursement of any project expenses in the summer or early fall of 2019 that could be reimbursed from a 2019 General Obligation Bond should the Board proceed to bond for renovations and facility improvements in 2019, 2020, and 2021. Board Secretary Jeff Johnson read the resolution to board members. Bill Groves made a motion to approve the resolution of official intent to reimburse expenditures and Christian Mattix seconded the motion. A discussion was held to review possible summer and fall projects before the motion was approved with a seven to zero vote.

3. Approve Overnight Girls’ Basketball Trip to Indiana State University on June 20 - 22, 2019

Mr. Ted Hayden requested permission to take 20 members of the Girls' Basketball Team to Indiana State University to participate in a two-day basketball clinic. The team will leave on June 20<sup>th</sup> and return on the 22<sup>nd</sup>. Bill Groves made a motion to approve the Girls' Basketball Team overnight trip to Indiana State University. Christian Mattix seconded the motion, and the motion passed with a vote of seven to zero.

Mr. Reese announced that a donation of \$100,000 was received by the John Glenn Education Foundation from the Branson and Mary Lou Hiatt Family Trust to be used for post-secondary scholarships.

Mr. Reese further recognized his outstanding Administrators for their dedication to students, staff, and duty. Mr. Reese noted that he thoroughly enjoyed his time working at John Glenn for the past 34 years and will truly miss the people with whom he has built relationships.
