School Board Meeting – June 4, 2013 Regular & Executive Session

CALL TO ORDER AND ROLL CALL – 7:00 P.M.

ESTABLISH A QUORUM AND PLEDGE OF ALLEGIANCE

The Board of School Trustees of the John Glenn School Corporation met in regular session at 7:00 p.m. on May 21, 2013, at the John Glenn Administration Building. Board members present were Jeff Johnson, Dennis Holland, Janice Ryan, Curt Pletcher, Bill Groves, Tom McCormick and Bob Borlik. Richard Reese, Superintendent, and 4 observers were also present.

RECOGNITIONS (WES, NLES, UMS, JGHS)

The Walkerton Elementary fourth nine-weeks and semester honor rolls were presented to the Board. Second grader Braylin Smith was recognized for his fundraising efforts for Spinal Muscular Atrophy. Braylin raised \$225.50 this past spring during Soccer season, and will be participating in the "Walk and Roll" event at Bethel College on July 23, 2013. Mrs. Oke's second grade class read over 74,000 minutes throughout this school year; the Board was asked to accept a donation of \$100 from the WES PTA for third grade school planners for the 2013-2014 school year.

North Liberty Elementary recently held their sixth grade celebration and the following students received awards: Emma Delinski and Gabriel Weiss received the Tri Kappa Outstanding 6th Grade Student Award; Abigail Houser received the Kevin Russell Math Award; Hope Dehoff received the Stanley Mlekodaj Award; Taylor Murray and Zachary Mago received the Cyndy Williams Award.

The Urey Staff was recognized for contributing to a great school year. ISTEP+ scores will not be released until July due to the technical issues experienced state-wide. The Urey Field Day was a success again this year thanks to the efforts of Brooke LaBere and Donia Hudgen. Students were eager to participate in events and enjoyed the spirit of homeroom competitions. Congratulations to Mr. Ponder's and Mr. Groves' homerooms, as they were the grade level champions.

In sports news, Tyler Prentkowski took 2nd place at the South Bend Golf Sectional with a score of 72. He advances to the regional match in Warsaw on Thursday, June 6, 2013.
