Regular Session

CALL TO ORDER AND ROLL CALL – 7:00 P.M.

ESTABLISH A QUORUM AND PLEDGE OF ALLEGIANCE

The Board of School Trustees of the John Glenn School Corporation met in regular session at 7:00 p.m. on July 10, 2013, at the John Glenn Administration Building. Board members present were Jeff Johnson, Dennis Holland, Janice Ryan, Curt Pletcher, Bill Groves, Tom McCormick and Bob Borlik. Richard Reese, Superintendent, and 6 observers were also present.

PUBLIC RESPONSE

Parent Jodi Auer was present to speak to the Board about transfer tuition cost. A discussion was held to explain the method of determining the annual cost of tuition, and why charging tuition to out-of-district students is so important financially to the John Glenn School Corporation.

A discussion was held concerning the Capital Projects Fund (CPF) list. Brad Schmeltz was commended for the proactive role in preventative maintenance of the school buildings.

Mr. Reese, Mr. Pletcher, Mr. Johnson, Mr. Holland and Mrs. Ryan attended the Indiana AP Recognition Banquet in June. Mrs. Ryan reported that she was impressed with the numbers of the recipients, and was proud of John Glenn for being one of the top 35 schools receiving this award; there are over 380 schools in Indiana. This was the second year in a row John Glenn High School was selected to be a part of the exclusive group of schools.

Jeff Johnson reported that information from the ISBA School Budget Finance Seminar stated that schools will see a 2% increase in funding this year, and another 1% next year.
