School Board Meeting – September 6, 2011 Regular Session

CALL TO ORDER AND ROLL CALL - 7:00 P.M.

ESTABLISH A QUORUM AND PLEDGE OF ALLEGIANCE

The Board of School Trustees of the John Glenn School Corporation met in regular session at 7:00 p.m. on September 6, 2011 in the John Glenn Administration Building. Board members present were Mike Daube, Jeff Johnson, Dennis Holland, Janice Ryan, and Tom McCormick. Bill Groves and Curt Pletcher were absent. Superintendent, Richard Reese, and four observers were also in attendance. The meeting began with the Pledge of Allegiance led by school board president Jeff Johnson.

RECOGNITIONS

Tim Davis, Principal of Walkerton Elementary School, recognized the WES PTA and staff for a successful open house on Thursday, August 18, 2011. Open house attendance was around 70%. WES was notified that it was the recipient of the Walmart Teacher Recognition Award. The award came from the Walmart in Plymouth. By the first of October a drawing will be held where 10 names will be drawn and the 10 staff members whose names are drawn will receive a \$100 gift card to Walmart. The staff and students of WES were thanked for making the first three weeks of school successful. The board was asked to accept donations from the following people and organizations of paper, pencils, crayons, notebooks, etc.: Tyner United Methodist Church, Walkerton United Methodist, North Liberty Church of Christ, and recess items from Suncrest Church.
