# School Board Meeting – September 16, 2014 Regular & Executive Session

# CALL TO ORDER AND ROLL CALL – 7:00 P.M.

#### ESTABLISH A QUORUM AND PLEDGE OF ALLEGIANCE

The Board of School Trustees of the John Glenn School Corporation met on September 16, 2014 at the John Glenn Administration Building. Board members present were Dennis Holland, Bob Borlik, Jeff Johnson, Tom McCormick, Janice Ryan, and Bill Groves. Curt Pletcher was absent. Richard Reese, Superintendent, and five observers were also present.
