School Board Meeting – April 16, 2015 Regular & Executive Session

CALL TO ORDER AND ROLL CALL - 7:00 P.M.

ESTABLISH A QUORUM AND PLEDGE OF ALLEGIANCE

The Board of School Trustees of the John Glenn School Corporation met in regular session at 7:00 p.m. on April 16, 2015, at the John Glenn Administration Building. Board members present were Janice Ryan, Jeff Johnson, Dennis Holland, Bob Borlik, and Bill Groves. Curt Pletcher and Tom McCormick were absent. Richard Reese, Superintendent, and 11 observers were also present.

Mr. Tim Davis announced that Gabby Smith, 5th grader, will represent WES in the Marshall County Spelling Bee. The competition will be held on Thursday, April 23 at Culver Community Jr-Sr High School. Ira Indekina won second place at the State Science Fair for the second year in a row, and the Walkerton Cafeteria again received a perfect inspection from the Health Department. The 7th and 8th grade Concert Band received a Gold rating while the 7th and 8th grade Concert Choirs received Gold ratings as well. Bill Groves made a motion to approve Consent Agenda Items 1 - 3, and Jeff Johnson seconded the motion. The motion passed with a five to zero vote.

NEW BUSINESS

1. Approve Equipment Purchase for Broadcasting Studio - \$49,289.57

A short discussion was held to review equipment being purchased for the new broadcasting studio. Bill Groves made a motion to approve the purchase of equipment for the broadcasting studio at a purchase price of \$49,289.57 plus shipping. Jeff Johnson seconded the motion and the motion passed with a five to zero vote.

2. Approve Purchase of Project Lead the Way Equipment and Supplies - Year 1 - \$82,300

Mr. Bob Gendron, Industrial Tech teacher, was present at the meeting to answer questions from the Board concerning the equipment needs for the Project Lead the Way (PLTW) classroom. A motion was made by Bill Groves to approve the PLTW four-year plan expense, with year-one set at \$82,300, year-two at \$22,200, year-three at \$39,200 and year-four at \$9,200. Dennis Holland seconded the motion, and the motion passed with a five to zero vote.

3. Approve Bid for John Glenn High School Track Resurfacing

Mr. Dana Wanamaker, of Barton-Coe-Vilamaa, Submitted his bid recommendation to the Board. Mr. Wanamaker recommended using Alternate #1 from Walsh & Kelly, Inc., at the bid amount of \$224, 438. Alternate #1 includes grinding up the existing track, repacking it, then adding new paving and rubber coating, as well as reconstruction of the long jump and pole vault. Jeff Johnson made a motion to approve the John Glenn High School track resurfacing bid, Alternate #1, at \$224, 438. Bill Groves seconded the motion, and the motion passed with a vote of five to zero.

4. Approve Fund Payment Requisition - \$4,622.68 for Ag Room Updates

Mr. McLochlin's teaching space at the high school has been expanded. With his growing Agriculture program, more classroom space was needed. Payment for the building expenses will be taken from the Refinance Bond account and must be approved by the Board. Bill Groves made a motion to approve the fund payment requisition for \$4,622.68 for the Ag Room updates. Jeff Johnson seconded the motion, and the motion passed with a vote of five to zero.

5. Revise Policy 6320 - First Reading

Mr. Reese asked the Board to consider raising the purchasing amount requiring board approval from \$5,000 to \$10,000. A short discussion was held before Bill Groves made a motion to approve Policy 6320 to reflect the change in approval amount from \$5,000 to \$10,000. Janice Ryan seconded the motion, and the motion passed with a vote of five to zero. This policy revision will be presented again at the next board meeting as all policy changes require two readings and approvals.

6. Approve J.E.S.S.E. Special Education Agreement

Mr. Reese provided to the Board for approval the joint service agreement between Union North and John Glenn School Corporation. Bill Groves made a motion to approve the J.E.S.S.E. Special Education Agreement and Jeff Johnson seconded the motion. The motion passed with a vote of five to zero.

Mr. Reese reported that the annual bus inspection was held this week and all 35 buses in the fleet passed the inspection. Mr. Reese recognized Mrs. King for her outstanding work as Transportation Director.
