# School Board Meeting – September 15, 2015 Regular & Executive Session

## CALL TO ORDER AND ROLL CALL - 7:00 P.M.

### ESTABLISH A QUORUM AND PLEDGE OF ALLEGIANCE

The Board of School Trustees of the John Glenn School Corporation met in regular session at 7:00 p.m. on September 15, 2015, at the John Glenn Administration Building. Board members present were Jeff Johnson, Dennis Holland, Bob Borlik, Curt Pletcher, and Tom McCormick. Bill Groves and Janice Ryan were absent. Richard Reese, Superintendent, and nine observers were also present.

#### RECOGNITIONS (WES, NLES, UMS, JGHS)

Mr. Tim Davis, Walkerton Elementary Principal, reported that WES is hosting the first week of their annual VIP Days. This is an opportunity for grandparents, parents and other Very Important People to enjoy a light snack with their grandchildren or special child, and visit the classroom to see what is happening in school. Mr. Davis announced the students and staff of WES recently held a "Penny War" to raise money for the Student Emergency Fund. This money is used to help students and families who are in difficult or emergency situations. Approximately \$1,026 was raised in four days.
