## School Board Meeting – February 7, 2017 Regular & Executive Session

## CALL TO ORDER AND ROLL CALL - 7:00 P.M.

#### ESTABLISH A QUORUM AND PLEDGE OF ALLEGIANCE

The Board of School Trustees of the John Glenn School Corporation met in regular session at 7:00 p.m. on February 7, 2017, at Urey Middle School. Board members present were Janice Ryan, Jeff Johnson, Dennis Holland, Christian Mattix, and Bob Borlik. Curt Pletcher and Bill Groves were absent. Richard Reese, Superintendent, and 11 observers were also present.

#### RECOGNITIONS (WES, NLES, UMS, JGHS)

Walkerton Elementary School hosted their annual Science Fair on Friday, February 3, 2017. Judges for the event were Matt Kiel, Becca Paul, Ryan Knowlton, Dave Craft, Andy Stegmiller and Sarah Hammond. PTA volunteers included Tricia Vickers, Dania Bocanegra, Raquel Snyder and Nancy Buford. Students who will move on to the Notre Dame competition include Jasper Kellems, Michaela Hurford, Emma Knowlton and Josh Knowlton. In sporting news, the WES 4th grade Girls' Basketball team won the tournament at Holy Cross on Sunday, January 15, 2017. On Friday, January 13, 2017, the WES PTA held their Winter Lock-In with 180 students attending. Recognition for hard work was given to all the teachers, aides and PTA volunteers who participated. In closing Walkerton recognitions, the Travel League Sixth Grade Basketball Team, consisting of players from both WES and NLES, finished their season undefeated, and the WES Cafeteria received a "perfect Inspection" from the Health Department on January 23, 2017.

#### **NEW BUSINESS**

#### 1. Approve Academic Decathlon Overnight Stay – February 10, 2017

Academic Decathlon Coach, Jeremy Merrill, asked the Board for permission for an overnight stay in Lafayette. The Academic Decathlon Team has advanced to the State Competition to be held at Purdue University beginning Friday, February 10<sup>th</sup> at 6:00 p.m. The competition will continue on Saturday morning, hence the need for students to stay overnight in Lafayette on Friday. Janice Ryan made a motion to approve the Academic Decathlon Team overnight stay in Lafayette on Friday, February 10, 2017. Bob Borlik seconded the motion, and the motion passed with a vote of five to zero.

## 2. Approve Auditioned Choirs Overnight Stay – February 25, 2017

Choir Director, Jordan Dollins, requested an overnight stay in Indianapolis on Saturday, February 25, 2017, for show choir students. Mr. Dollins and students will travel to Indianapolis on February 25 to work with Ball State Professor, Dr. Kerry Glann. On Sunday, students will attend a choral-orchestral performance of Carmina Burana in Carmel. Christian Mattix made a motion to approve the choir student overnight stay in Indianapolis on February 25, 2017. Dennis Holland seconded the motion, and the motion passed with a vote of five to zero.

## 3. Approve Purchase of 200 iPads for North Liberty and Walkerton Elementary Schools

Andy Stegemiller asked the Board to approve the purchase of 200 additional iPads for NLES and WES, for use in Kindergarten, First, and Second grades. This purchase includes charge carts and cases as well. The total purchase price for 200 iPads, 200 cases, and 11 carts from Apple Computer will be \$101,589.45. Mr. Stegemiller noted that the purchase would be paid from the Common School Loan fund. A lengthy discussion was held in an effort to determine the benefit of technology versus textbooks, after which Mr. Stegemiller answered questions from the Board. Janice Ryan made a motion to approve the purchase of 200 iPads, 200 cases, and 11 charging carts from Apple Computer for \$101,589.45. Dennis Holland seconded the motion, and the motion passed with a vote of five to zero.

### 4. Approve Water Softener Purchases for Walkerton, Urey, and John Glenn High Schools

Brad Schmeltz submitted to the Board bids for adding water softeners to each of the Walkerton school buildings. Due to the town discontinuing their water softening efforts, Mr. Schmeltz felt it was important to install water softeners in each of the buildings to save on cafeteria equipment maintenance. The winning bid was from Aqua Systems for \$22,076 for equipment for all three buildings. D.A. Dodd submitted a bid for installation of the equipment at a not to exceed price of \$11,500 per building. After a brief discussion, Bob Borlik made a motion to approve the purchase of water softener equipment and installation at a price (not to exceed) of \$56,576 for Walkerton Elementary, Urey Middle, and John Glenn High Schools. Dennis Holland seconded the motion, and the motion passed with a vote of five to zero.

# 5. Approve First Reading of NEOLA Policies Additions and Revisions—Volume 29, No. 1 and Technology Special Release Phase I

Janice Ryan made a motion to approve the First Reading of NEOLA Policies additions and revisions for Volume 29, Number 1 and Technology Special Release Phase I. Bob Borlik seconded the motion, and the motion passed with a vote of five to zero.

## 6. Approve Resolution for Account Transfer from General Fund to Rainy Day Fund

Mr. Tom Bendy, Treasurer, asked the Board to approve a resolution to transfer \$74,962.74 to the Rainy Day fund from the General Fund. This transaction was requested due to an early payout of the 2016 Teacher Performance Grant from the Rainy Day Fund. A short discussion was held before Janice Ryan made a motion to approve the Resolution for Account Transfer of \$74,962.74 from the General Fund to the Rainy Day Fund. Dennis Holland seconded the motion and the motion passed with a vote of five to zero.

#### 7. Approve Acceptance of Lilly Planning Grant - \$30,000

Mr. Richard Reese, Superintendent, reported that John Glenn School Corporation has received a planning grant of \$30,000 under Lilly Endowment Inc.'s Comprehensive Counseling Initiative for Indiana K-12 Students. Melanie Heiser, Grant Writer and Lead Contact for the Grant, anticipates using the grant to seek out research, assess current counseling programs, and to engage the educational community in analyzing data and exploring alternative strategies and best practices in the counseling profession. John Glenn School Corporation is one of 284 Indiana public school corporations and charter schools in Indiana receiving planning grants through the initiative. Christian Mattix made a motion to accept the Lilly Planning Grant of \$30,000, and Janice Ryan seconded the motion. The motion passed with a vote of five to zero.

#### 8. Approve FMLA Requests for Maternity Leaves – Brittney Savill and Sarah Martin

Two teachers from North Liberty Elementary, Sarah Martin and Brittney Savill, have requested Maternity Leave. Dennis Holland made a motion to approve the Maternity Leaves for Sarah Martin and Brittney Savill. Bob Borlik seconded the motion, and the motion passed with a vote of five to zero.

#### 1. Superintendent's Report

Mr. Reese unveiled the John Glenn Education Foundation website, which was created through the hard work of Stacy Pecsi, for board members. Mr. Reese emphasized the website is still under construction, but highlighted key features of the site to the board. Mr. Reese also noted that the Hiler house is still on

the market at this time, but is hoping the house will sell in the spring. Mr. Reese noted the tag sale will be held on April 8, 2017, through the leadership of Jessica Chamberlin, JGEF Fundraising Committee Chairperson.
