# School Board Meeting - November 7, 2017 <br> Regular \& Executive Session 

## EXECUTIVE SESSION

An executive session was held to discuss Collective Bargaining. No other business was discussed. ## ESTABLISH A QUORUM AND PLEDGE OF ALLEGIANCE

The Board of School Trustees of the John Glenn School Corporation met in regular session at 7:07 p.m. on November 7, 2017, at the John Glenn Administration Building. Board members present were Jeff Johnson, Bob Borlik, Dennis Holland, Curt Pletcher, Christian Mattix, Bill Groves, and Janice Ryan. Richard Reese, Superintendent, and thirteen observers were also present.

## RECOGNITIONS (WES, NLES, UMS, JGHS)

Mr. Tim Davis, Walkerton Elementary Principal, announced that the WES Spell Bowl team will travel to North Liberty on Thursday, November 16 to compete in the Elementary version of the Hoosier Spell Bowl. The Summer Reading Program held their second Tyner IOOF Fish Fry on Friday, November 3. This event was well attended with an estimated profit of $\$ 2,100$. The Fifth and Sixth Grade Fall Basketball Lock-In will be held on Friday, November 17, from 6:00 p.m. to 8:00 p.m. Mr. Ryan Reese and Mr. Jay Walter are organizing this event. On October 31, Mrs. Snyder's preschool students, all three kindergarten classes, and Ms. Mackowiak's students, walked to Miller's Merry Manor to participate in the annual Trick-or-Treat event with the residents. ## NEW BUSINESS

1. Appoint Library Board Member to the St. Joseph Public Library

The St. Joseph Public Library Board asked the School Board to appoint Terry Rensberger, in a joint appointment with Union-North United School Corporation, to the St. Joseph County Public Library Board. This appointment will be for four years, beginning on January 1, 2018. Bill Groves made a motion to approve the appointment of Terry Rensberger to the St. Joseph County Public Library for a four year term beginning January 1, 2018. Bob Borlik seconded the motion, and the motion passed with a vote of seven to zero.

## 2. Approve Overnight Stay for John Glenn FFA on December 8, 2017

Mrs. Lynnette Markley asked the board for permission to take a group of FFA students to the Rossville Crops and Forestry Invitational on Friday, December 8, 2017 in Lafayette, Indiana. The State Competition begins Saturday, December 9 at 7:30 a.m. Janice Ryan made a motion to approve the FFA overnight trip to Lafayette, Indiana on December 8, 2017. Bill Groves seconded the motion, and the motion passed with a seven to zero vote.

## 3. Approve Early Graduation Requests for Five Students

Mr. Morton introduced to the Board three of the students requesting early graduation. Those students were Brene Osenbaugh, Clayton Humphrey, and Nolan Heying. Dakota Grossman and Jamie Freeman were not present at the meeting and the Board asked to review their requests at the November 21 meeting, pending attendance of those two students. Curt Pletcher seconded the motion, and the motion passed with a seven to zero vote.
4. Approve JGEA/JGSC Master Teacher Contract effective July 1, 2017 to June 30, 2019

This is a two-year agreement with JGEA, agreeing the starting teacher pay would be $\$ 36,000$. Other major changes and revisions include changing Spanish Club Sponsor to Robotics Coach in the Elementary, increasing webmaster pay at all buildings by 5\%, increasing High School Vocal Music Director by $5 \%$, and adding AP/CE Coordinator (only paid if no planning period assigned) at $\$ 1,875$. A short discussion was held before Bill Groves made a motion to approve the JGEA/JGSC Master Teacher Contract, effective July 1, 2017 to June 30, 2019. Janice Ryan seconded the motion and the motion passed with a vote of seven to zero.

## REPORTS

1. Superintendent's Report

Mr. Reese provided to the Board a list of recent Teacher Grant recipients. Those individuals include Kurt Foster, Kay Freehauf, Dara Goodlink, Dawn Marks, Dyan Phillips, Donna Rummel, Leslie Stec, Jennifer Traub, and Amy Weiss. Mr. Reese noted that the total of these first semester grants is $\$ 6,198.52$. Second semester grants will be awarded by the first of the year, with $\$ 5,801.48$ available to teachers.

Mr. Reese also noted the upcoming John Glenn Education Foundation Gala, which will be held at Swan Lake on February 17, 2017. Tickets will be $\$ 75$ per couple and will include dinner, dancing, and a silent auction.
