School Board Meeting – November 21, 2017 Regular & Executive Session

CALL TO ORDER AND ROLL CALL - 7:07 P.M.

ESTABLISH A QUORUM AND PLEDGE OF ALLEGIANCE

The Board of School Trustees of the John Glenn School Corporation met in regular session at 7:00 p.m. on November 21, 2017, at the John Glenn Administration Building. Board members present were Jeff Johnson, Bob Borlik, Christian Mattix, Bill Groves, and Janice Ryan. Dennis Holland and Curt Pletcher were absent. Richard Reese, Superintendent, and eight observers were also present.

<u>RECOGNITIONS</u> (WES, NLES, UMS, JGHS)

Mr. Tim Davis, Walkerton Elementary Principal, announced that on Thursday, November 16, 2017, the WES Spell Bowl team took first place in the Elementary Spell Bowl. Statewide, WES placed 21st out of 113 schools in their division. Perfect spellers were Isaiah Payne, Olivia Foresman, Nina Foresman and Kaleb Cobe. Near perfect spellers were Ariel Gates and Emma Knowlton. Team members include Fifth Graders Julie Irvine, Ariel Gates, Kaiylen Turnage, Nina Foresman, Olivia Foresman, Michaela Hurford, Jasper Kellem, Ben Kozora, and Kaleb Kobe. Sixth Grade team members include Helen Guseilla, Katelyn Vermilyer, Taylor Swank, Emma Kowlton and Isaiah Payne. The Sixth Grade A and B Boys' Basketball teams competed at the LaVille Preseason Tournament on Saturday, November 11, 2017. Although neither team took the championship, both teams played strong. Karlie Gibson, Kindergarten Teacher, was recognized by the Department of Education at the annual Teacher-of-the-Year Banquet on Friday, November 17, 2017 in Indianapolis. In closing, Mr. Romer announced the Student Council Canned Food Drive was very successful. Mr. Romer thanked the Sixth Grade Student Council and Shamrock families for donating items to support the John Glenn Community. Mr. Mark Maudlin, Urey Middle School Principal, congratulated the Urey Spell Bowl team and their coach, Wendy Peters for being named Indiana Class 3 State Spell Bowl Champions on Saturday, November 11, 2017, at Purdue University. The team spelled 63 out of the 72 words correctly to bring home the championship.
