2. Review and Approve 2019-2020 School Calendar

Mr. Richard Reese, Superintendent, reviewed the school calendar with the Board, noting that the 19-20 calendar is very similar in format to the 18-19 calendar. Jeff Johnson made a motion to approve the 20192020 calendar and Christian Mattix seconded the motion. The motion was approved with a vote of seven to zero.

## 3. Approve Resolution to Establish Initial Funding for the Education Fund

A short discussion was held to review the process required to create the Education and Operations Funds. New business items three through six are part of that process and must be approved by the Board per state guidelines. Bob Borlik made a motion to approve the Resolution to establish initial funding for the Education Fund. Bill Groves seconded the motion, and the motion passed with a vote of seven to zero.

## 4. Approve Resolution to Establish Initial Funding for the Operations Fund

Bill Groves made a motion to approve the Resolution to establish initial funding for the Operations Fund. Christian Mattix seconded the motion, and the motion passed with a seven to zero vote.
5. Approve Resolution to Transfer Amounts from the Education Fund to the Operations Fund

Bill Groves made a motion to approve the Resolution to transfer amounts from the Education Fund to the Operations Fund. Jeff Johnson seconded the motion, and the motion passed with a seven to zero vote.
6. Approve Resolution of Transfers of Appropriations of General and Transportation Funds

This is an annual resolution the Board approves to allow transfers within the General (Education) and Transportation (Operations) Funds. Indiana Statute requires that all appropriations in the main funds have a zero or positive balance, and this transfer brings negative appropriation balances to zero. A comprehensive list of the transfer amounts was available at the board meeting for review. Bill Groves made a motion to approve the Resolution of transfers of appropriations as presented. Curt Pletcher seconded the motion, and the motion passed with a vote of seven to zero.

Mr. Richard Reese, Superintendent, commented on the new flooring and furniture in the Walkerton Elementary Cafeteria, noting that John Glenn High School also has new cafeteria furniture.
