## CALL TO ORDER AND ROLL CALL - 7:00 P.M.

The Board of School Trustees of the John Glenn School Corporation met in regular session at 7:00 p.m. on November 19, 2019, at the John Glenn Administration Office. ## NEW BUSINESS

## 1. Approve Seven-Semester Graduate Requests

Seniors, Sara Lutin and Aaron Wright, asked the School Board for permission to graduate in December. Both students will have completed the necessary credits to graduate by December 20, 2019. A short discussion was held before Jeff Johnson made a motion to approve the early graduation requests of Sara Lutin and Aaron Wright. Bob Borlik seconded the motion, and the motion passed with a four to zero vote.
2. Approve School Improvement Plans for WES, NLES, UMS, and JGHS

Mr. Chris Winchell, Superintendent, noted that per Indiana Code, the School Improvement plans must have official approval by the School Board. These are three-year plans but it is corporation practice to update them on a yearly basis. Several board members commented on how well-written and wellbalanced the plans were before Jeff Johnson made a motion to approve the School Improvement Plans as presented. Dan Drotar seconded the motion, and the motion passed with a four to zero vote.

## REPORTS

## 1. Superintendent's Report

Mr. Chris Winchell, Superintendent, reported that 14 teachers traveled to Indianapolis to participate in "Red for Ed" day at the capitol. Mr. Winchell stated he received feedback from parents both supporting the choice to stay open and others disappointed that the corporation did not close.

Mr. Winchell next reported that the Teacher Appreciation Grant has been calculated and teachers rated Highly Effective will receive $\$ 660$ before taxes. Teachers rated Effective will receive $\$ 533$ before taxes.

Mr. Winchell asked the Board for permission to move forward planning an eLearning day. After a short discussion, the School Board gave Mr. Winchell permission to move forward with eLearning planning. Mr. Winchell stated he tentatively plans to use President's Day as the first eLearning day, if a snow makeup day is needed. A committee has been formed and will work together to develop an effective eLearning program.

Mr. Tim Davis, WES Principal, and Mr. Winchell, recently met with Oaklawn Representative, Greg Fry, to discuss Trauma Informed Instruction training for staff members. Mr. Winchell noted that this concept is not new to John Glenn. Administrators and staff have stressed the importance of building relationships with students in order to better understand their emotional needs, and therefore improve on teaching methods needed for effective instruction.

Mr. Winchell presented two proposed 2020-2021 calendars for the Board's review. Mr. Winchell asked board members to review the options and bring their suggestions to the next meeting.

In closing, Mr. Winchell reminded board members that the next board meeting will be held at North Liberty Elementary School and the John Glenn High School Theatre will perform "Clue!" the weekend of November $22-24$. Performances will start at $7: 30$ p.m. on Friday and Saturday, with a matinee performance on Sunday at 2:00 p.m.
